Most front yard landscaping projects do not require a change request form either. For example, plantings of approved plants do not require prior approval. There are some plants that are prohibited in the front yard, for example, palm trees, olive trees, oleanders, and grass. As a general guideline, please submit an Architectural Change Request for the following landscaping projects.

- Construction of or altering the appearance of the walkway in the front yard
- Installing a fountain
- Erecting a flag pole

- Extending the driveway or altering the appearance of the driveway
- Any excavation or grading work

## Solar Photo Voltaic (PV) Electric Systems

Carino Canyon has established the following guidelines for the installation of solar photo voltaic (PV) electrification systems. If you are planning on installing solar collectors for the purpose of supplementing your commercial electric system, review these guidelines and submit the required documentation with this request.

Carino Canyon HOA recommends that the home owner submit these guidelines to the contractor responsible for the PV installation and gain their agreement and concurrence before installation.

#### **Documentation**

- 1. Provide the full name, address and contact information of the vendor installing the system.
- 2. Provide the specifications for the solar PV system. This should be obtained from your installation vendor and should include:
  - A description of the solar panel array to include the tilt angle to the sun, number of panels, the KVa (i.e., power output), etc
  - The location, size and number of the panels on the roof (i.e., south, west, etc.). Include a drawing or sketch to show the total area to be installed.
  - A description of how electrical cables are to be routed to the home and to the APS meter / circuit breaker hox
- 3. Approval by the electric utility (APS). Provide a copy of the approval letter or other notification.

### **Design Guidelines**

- All solar PV arrays must be installed on the roof.
- Tillted or elevated installations are discouraged. If installation is not to be installed flush with the roof, an explanation for the deviation must be included stating the reason (e.g., required for efficiency, or other reason, etc.) from the installation vendor or APS.
- Any installations that are to be elevated off the roof to clear sewage vent pipes and attic vents are allowed
  only on the rear of the roof. Installations on the front of the roof (facing the street) must be flush with the roof
  and, if required, any vents must be repositioned or re-rerouted. If an elevated installation is planned (i.e., not
  flush with the roof), provide a full description of the proposed installation and the reason for the elevation.
- All installations must comply with City of Scottsdale Building Codes.
- Electrical cables and conduits should be routed through the attic unless conditions do not allow. If cables / conduits will be exposed, an explanation stating the reason is required. Any exposed electrical cables and conduits must be installed and bundled in a tidy manner with no loose wires hanging from the installation. Exposed electrical cables, wires and conduits are to be anchored to the exterior or routed through the interior of the structure.
- Any exposed cables, conduits, mounting hardware, etc. to be painted house or trim color to blend into the structure as much as possible.
- All exposed frames for PV panels to be a dark color (anodized, powder-coated, painted or plated). Bright
  colors or unpainted (bare metal) components are not allowed (e.g., bare aluminum, white, or other bright
  colors). All metal framing material must also be anodized, powder-coated, plated or painted a dark color
  such as black or dark bronze.

### **Domestic Solar Hot Water Systems**

Carino Canyon has established the following guidelines for the installation of solar hot water collector systems. If you are planning on installing solar collectors for the purpose of heating of water for domestic use (including swimming pool), review these guidelines and submit the required documentation with this request.

If you are using a contractor, Carino Canyon HOA recommends that the home owner submit these guidelines to the contractor responsible for the solar hot water installation and gain their agreement and concurrence before installation.

#### **Documentation**

- 1. Provide the full name, address and contact information of the vendor installing the system.
- 2. Provide the specifications for the solar hot water system. This should be obtained from your installation vendor and should include:
  - A description of the solar panel types. Carino Canyon requires that the solar collectors be glazed panels.
  - The location, size and number of the panels on the roof (i.e., south, west, etc.). Include a drawing or sketch to show the total area to be installed.
  - A description of how any cabling and plumbing is to be routed to the inside of the home.
- 3. Approval by the City of Scottsdale. Provide a copy of the approval letter or other notification.

### **Design Guidelines**

- All solar collector arrays must be installed on the roof.
- Tillted or elevated installations are discouraged. If installation is not to be installed flush with the roof, an explanation for the deviation must be included stating the reason.
- Any installations that are to be elevated off the roof to clear sewage vent pipes and attic vents are allowed
  only on the rear of the roof. Installations on the front of the roof (facing the street) must be flush with the roof
  and, if required, any vents must be repositioned or re-rerouted. If an elevated installation is planned (i.e., not
  flush with the roof), provide a full description of the proposed installation and the reason for the elevation.
- All installations must comply with City of Scottsdale Building Codes.

Home Owner Signature

- Piping to and from the solar hot water collectors should be routed through the attic and must not be visible from common areas or adjacent homes. Piping must be run into the roof and through attic spaces or hidden from view in common areas.
- Any exposed cables, conduits, mounting hardware, piping etc. must be painted house or trim color to blend into the structure as much as possible.
- All exposed frames for solar panels to be a dark color (anodized, powder-coated, painted or plated). Bright
  colors or unpainted (bare metal) components are not allowed (e.g., bare aluminum, white, or other bright
  colors). All metal framing material must also be anodized, powder-coated, plated or painted a dark color
  such as black or dark bronze.
